RATE SCHEDULE 30

LARGE COMMERCIAL SERVICE - FIRM

AVAILABILITY

This rate schedule is available for gas service to Customers contracting for 5,000 therms of service per month.

The customer's property served under this rate schedule is located in the service area of Powell-Clinch Utility District (PCUD).

Gas supplied under this rate schedule is for the exclusive use of the Customer and shall not be resold.

Availability of gas under this rate schedule is subject to curtailment in the event of any curtailment of the District's supply of gas and is subject to adequate capacity being available from existing gas mains.

Gas sold under this rate schedule shall be interrupted only after gas sold under other rate schedules, having a lower priority than gas sold under this rate schedule has been curtailed. The District shall, however, have the right to curtail all gas sold under this rate schedule when, in its sole judgment, conditions are such as to require curtailment of the schedule.

MONTHLY RATE

Customer Charge: \$75.00 per month

Commodity Charge: \$0.4000 per therm

Turn On and/or Reconnect Charge: \$150.00

Purchased Gas Adjustment:

The above rates are subject to adjustment caused by changes in the cost of purchased gas in accordance with Service Schedule 10. Purchased gas adjustments and all applicable taxes and fees are in addition to the above stated base rate.

MINIMUM BILL

The minimum bill is the Customer Charge.

## MEASUREMENT

The unit of volume for the purposes of measurement shall be by the cubic foot. The unit of volume for the purpose of billing shall be by the therm. The number of therms delivered at the point of service shall be determined by multiplying the number of measured cubic feet of natural gas delivered to the customer during said month by the “Unit Total Heating Value” of each cubic foot and then dividing the total by 100,000.

## PAYMENT

The above rates are net, the gross rates being 10% higher. In the event the current monthly bill is not paid on or before delinquent date shown on the bill, the gross rates shall apply.

## CONTRACT REQUIREMENT

Customer taking service under this rate schedule shall be required to execute PCUD’s “Agreement for Firm Gas Sales Service” for a contract period of not less than one (1) year. All customers having a Monthly Demand of 5,000 therms or greater may receive annual and/or monthly volumetric allocations from the District.

## SINGLE POINT DELIVERY AND JOINT SERVICE THROUGH ONE METER

The above rates are based upon the supply of service to the Customer’s premises through a single delivery and metering point and at a single pressure. Separate supply for the same Customer at other points of consumption, or at different pressures shall be separately metered and billed.

## VOLUMETRIC RESTRICTIONS

The District reserves the right to require a new contract from any Customer whose Maximum Daily Demand is less than his Contract Demand, and further reserves the right to prohibit the addition of any loads in excess of present loads or present Contract Demands without prior District approval.

## RULES AND REGULATIONS

Service is subject to the Rules and Regulations of the Powell-Clinch Utility District.
